- Providing legal advice, assistance, and representation to young people who require the assistance of Youth Legal Service.
- Must be prepared to appear in both the Children's and Magistrates Courts on criminal matters and restraining orders, also do one off legal advice and tasks in both civil and criminal law matters, present at law education workshops for young people, have the conduct of criminal injuries compensation files and other civil casework.
- Work with the Principal Solicitor to ensure that all legal work undertaken by Youth Legal Service Inc., complies with the requirements of the Legal Profession Act 2015, Legal Profession Conduct Rules WA 2010, Professional Indemnity Insurance requirements and Youth Legal Service's policies and practice standards.
- Assist in the delivery of community legal education workshops.
- Contribute to the collaborative relationship between Legal Aid WA, Community Legal Centres WA, and other community organisations with whom Youth Legal Service interacts.
- Maintain effective file and diary management systems, administrative systems and procedures and quality assurance procedures as well as maintain statistics and other records required by funding bodies as required by the policies and procedures of Youth Legal Service.
