### The Organisation

For over 23 years, the Asylum Seeker Resource Centre (ASRC) has been providing support and advocating for the human rights of people seeking asylum, independent from any Federal government funding. Alongside refugees, the ASRC advocates for law reform and policy change, and provides programs to support and empower people seeking asylum to maximise their own physical, mental and social wellbeing.

## The Human Rights Law Program (HRLP)

The HRLP, an accredited Community Legal Centre within the ASRC, delivers expert, trauma-informed legal services to refugees and people seeking asylum facing significant barriers in accessing justice during the complex and lengthy refugee determination process. The HRLP represents people in the community in Victoria and in detention nationally and offshores services include referrals, advice, clinics (including a gender clinic), and full representation throughout the refugee status determination process.
